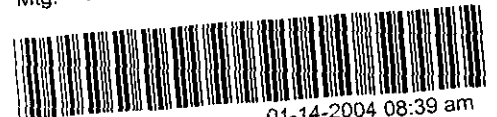

**SIXTH AMENDMENT TO THE DECLARATION OF
CONDOMINIUM FOR THE GREAT OUTDOORS PREMIER R.V./
GOLF RESORT I, A CONDOMINIUM**

THE GREAT OUTDOORS PREMIER R.V./GOLF RESORT I CONDOMINIUM ASSOCIATION, INC., a Florida corporation (the "Association"), pursuant to the authority reserved in Article VI of the Declaration of Condominium of THE GREAT OUTDOORS PREMIER R.V./GOLF RESORT I, a Condominium, and in the Florida Condominium Act, hereby amends the Declaration of Condominium dated November 29, 1988, and recorded on April 21, 1989, at Official Records Book 2991, Page 3077, et. seq.; as amended by [First] Amendment to Declaration dated September 30, 1994, and recorded on October 4, 1994, at Official Records Book 3425, Page 4521; as amended by [Second] Amendment to Declaration dated September 30, 1994, and recorded on October 4, 1994, at Official Records Book 3425, Page 4525; as amended by [Corrective Second] Amendment to Declaration dated January 9, 1995, and recorded January 12, 1995, at Official Records Book 3448, Page 1773; as amended by [Third] Amendment to Declaration dated July 21, 1995, and recorded August 11, 1995, at Official Records Book 3496, Page 3385; as amended by [Corrective Third] Amendment to Declaration dated October 23, 1995, and recorded October 28, 1995, at Official Records Book 3516, Page 0147; as amended by [Fourth] Amendment to Declaration dated September 23, 1995, and recorded October 28, 1995, at Official Records Book 3516, Page 0151; as amended by [Fifth] Amendment to Declaration as recorded December 22, 1999, at Official Records Book 4104, Page 0592, all of the Public Records of Brevard County, Florida (the "Declaration"), as follows:

Section 16.10 General Restrictions shall be amended in its entirety to read as follows:

16.10 General Restrictions. In order to maintain a community of congenial residents who are responsive to good management, the ~~Community Services~~ Association has certain restrictions. ~~The R~~estrictions of general interest are:

a) Owners and guests must be registered upon arrival and departure for security control. Guests include the invitees of Owners and the Developer, and include Rally participants.

b) Recreational facilities are for the sole use of residents and their guests. Hours of use and rules for use shall be posted.

- c) Speed limits are posted.
- d) The period of time from 11:00 p.m. to 7:00 a.m. each day shall be observed as the quiet hours.
- e) Alcoholic beverages are not permitted in any common elements of the Condominium, except for special events with the prior approval of the Association.
- f) No clotheslines, mailboxes, radio and/or television antennas shall be permitted on any Unit.
- g) No garbage or trash receptacles, other than those approved by the Association, shall be allowed on any Unit.
- h) Patio lights are allowed if approved by the Association.
- i) Motorcycles and minibikes are prohibited. No bicycles are permitted on the pool deck or walkways.

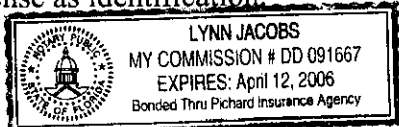
