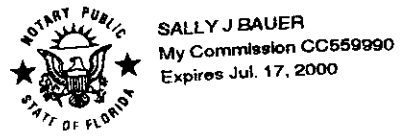

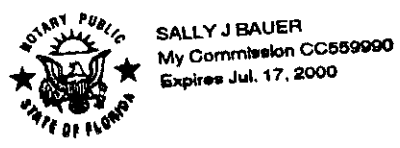

A parcel of land lying in Section 6, Township 23 South, Range 35 East, Brevard County, Florida, described as follows:

Beginning at the southwest corner of Unit 268 as shown on Exhibit A of the Great Outdoors Premier RV/Golf Resort II as recorded in Official Records Book 2998, page 1811 of the Public Records of Brevard County, Florida; thence S.82°58'29"E., along the south line of said Unit 268 and the easterly prolongation thereof, 97.05 feet to a point lying on the arc of a circular curve, concave westerly, having a radius of 1622.00 feet, and to which point a radial line bears N.86°36'21"E.; thence southerly, along the arc of said curve, through a central angle of 01°05'16", a distance of 30.80 feet; thence S.87°55'13"W., 25.18 feet; thence N. 60°54'22"W., 83.58 feet to a point lying on the arc of a circular curve, concave easterly, and having a radius of 298.00 feet; thence northerly, along the arc of said curve, through a central angle of 00°33'42", a distance of 2.92 feet to the Point of Beginning.

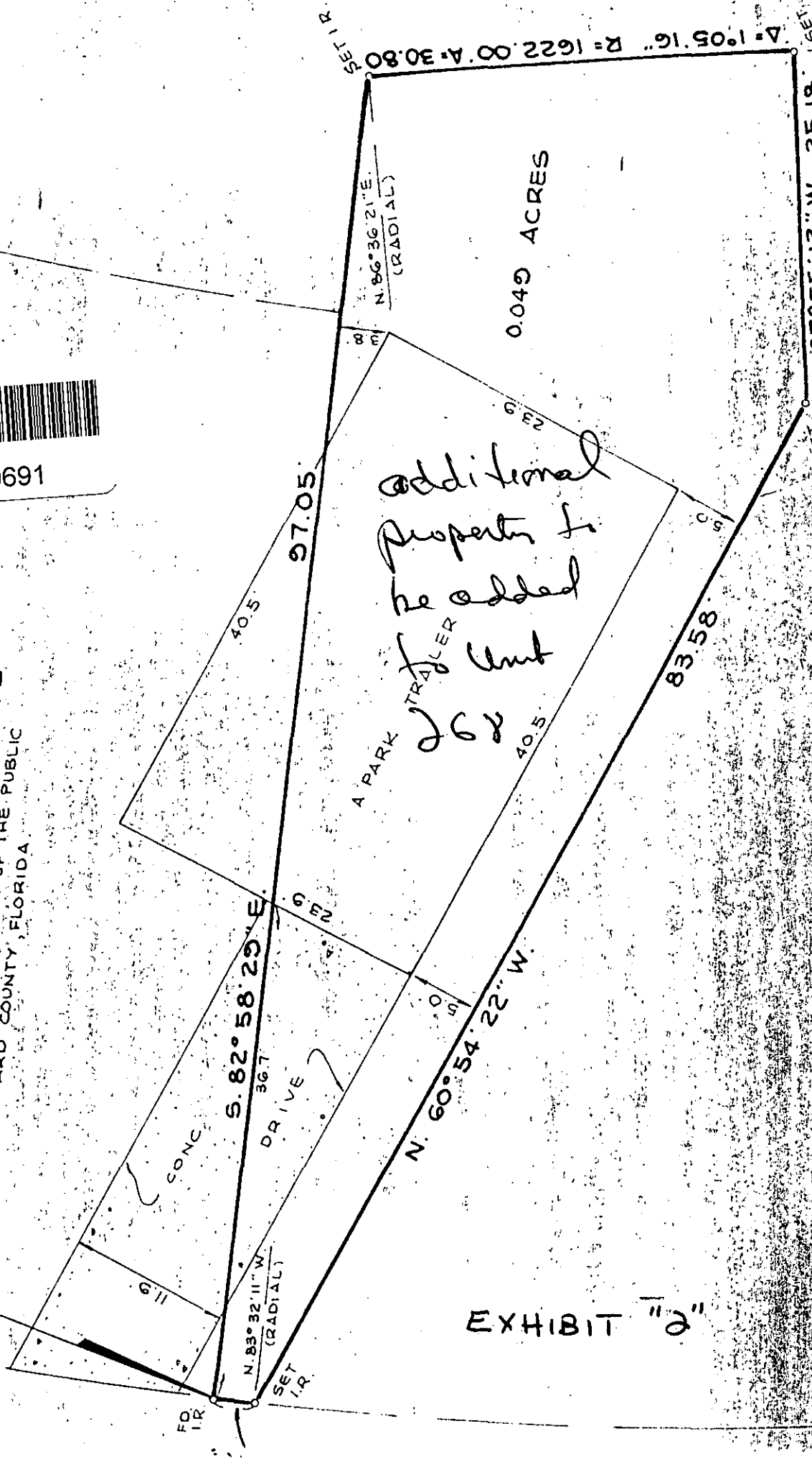
