SIXTH AMENDMENT TO DECLARATION OF CONDOMINIUM OF
THE GREAT OUTDOORS PREMIER R.V./GOLF RESORT III,
A CONDOMINIUM

THE GREAT OUTDOORS PREMIER R.V./GOLF RESORT III CONDOMINIUM ASSOCIATION, INC., a Florida corporation not for profit (the "Association"), pursuant to the authority reserved in Article XIII of the Declaration of Condominium of THE GREAT OUTDOORS PREMIER R.V./GOLF RESORT III, A CONDOMINIUM, and in the Florida Condominium Act, by a majority vote of the Board of Directors, hereby amends the Declaration of Condominium, as recorded in Official Records Book 3071, Page 4748; as amended by Amendment to Declaration dated April 5, 1991 and recorded in Official Records Book 3118, Page 3419; as amended by Second Amendment to Declaration dated June 28, 1994, and recorded in Official Records Book 3406, Page 411; as amended by Third Amendment to Declaration dated June 28th, 1994, and recorded in Official Records Book 3406, Page 0415; as amended by Fourth Amendment to Declaration dated June 28, 1994, and recorded in Official Records Book 3406, Page 0424; as amended by Corrected Fourth Amendment to Declaration dated August 3, 1994, and recorded September 6, 1994 in Official Records Book 3418, Page 4355; and as amended by Fifth Amendment to Declaration dated August 3, 1994, and recorded on September 6, 1994 in Official Records Book 3418, Page 4361, all of the Public Records of Brevard County, Florida (the "Declaration"), as follows:

1. Pages 3 and 11 of Exhibit A to the Declaration, are hereby deleted in their entirety and Page 3A attached hereto is substituted therefor.
2. Pages 3A, 11A and 16 attached hereto are added to Exhibit A to the Declaration. Page 16 adds Parcel 16 to the legal description and Page 11A combines Units 250 and 252 into Unit 250.

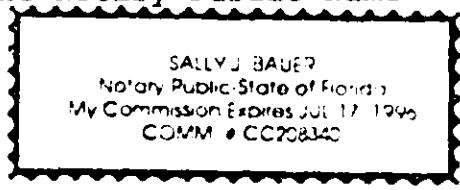

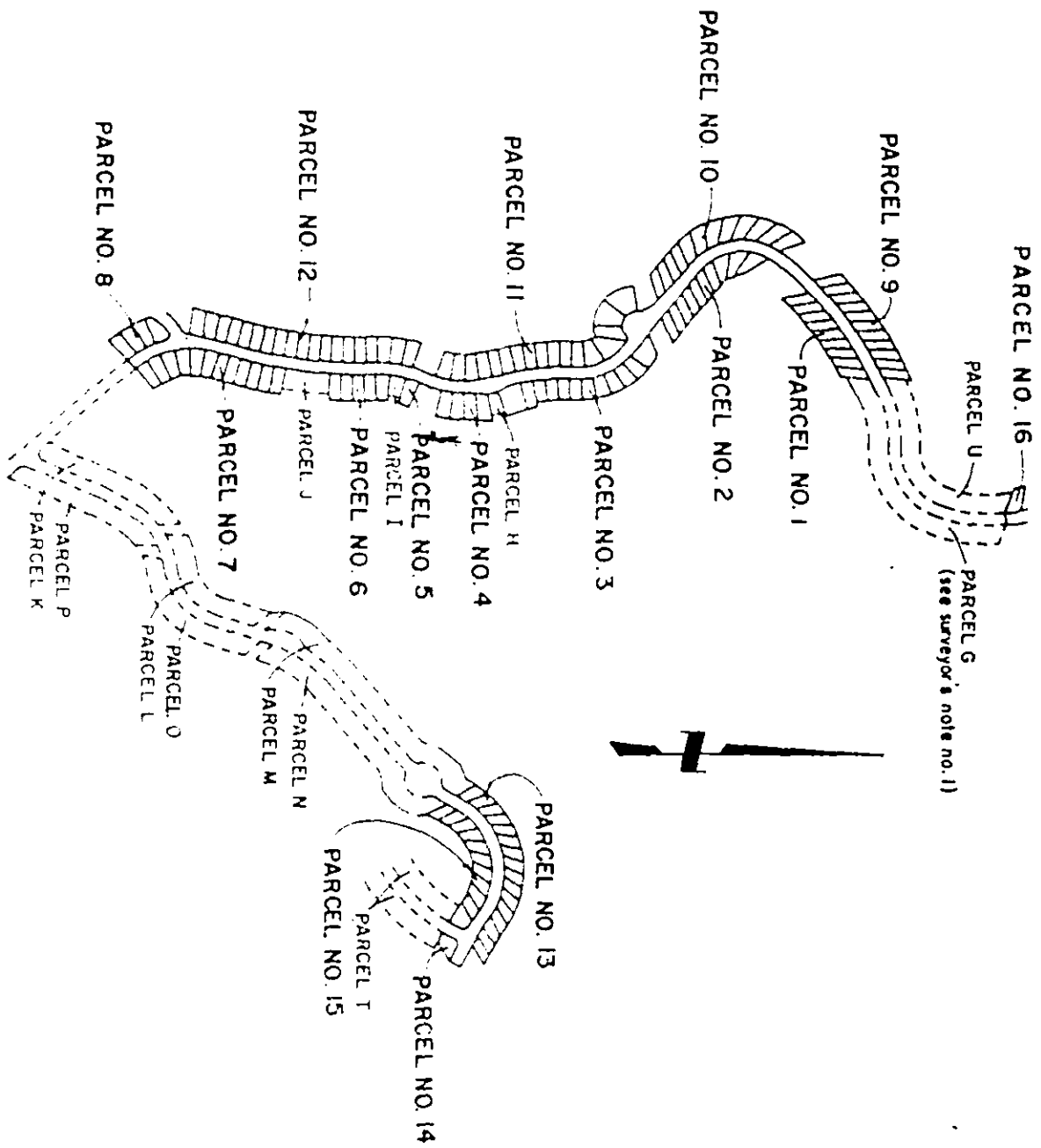

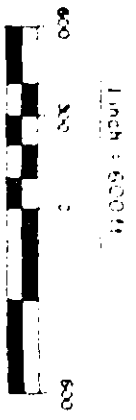




PARCEL PROXIMITY MAP

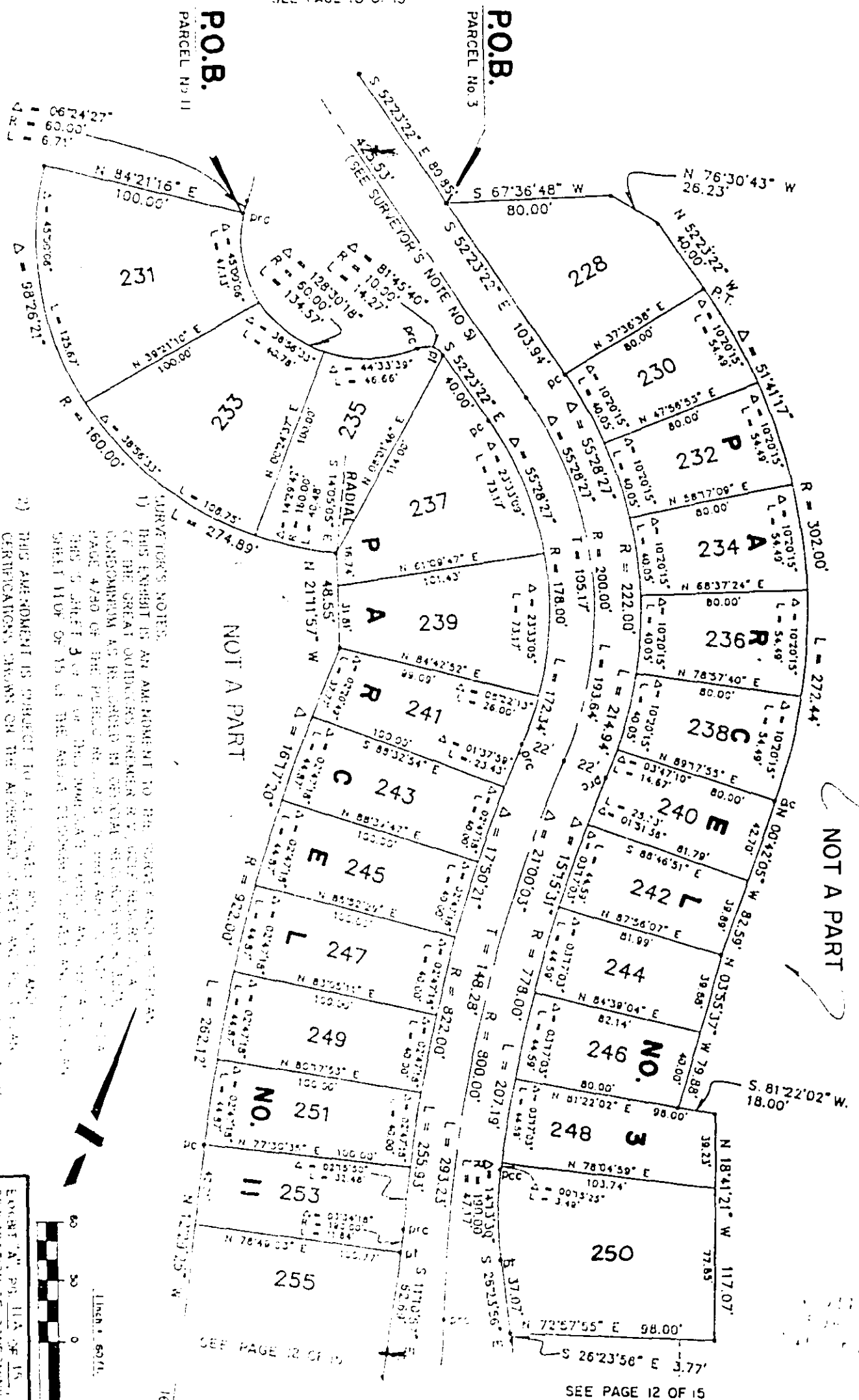

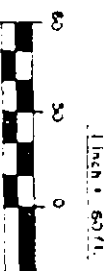
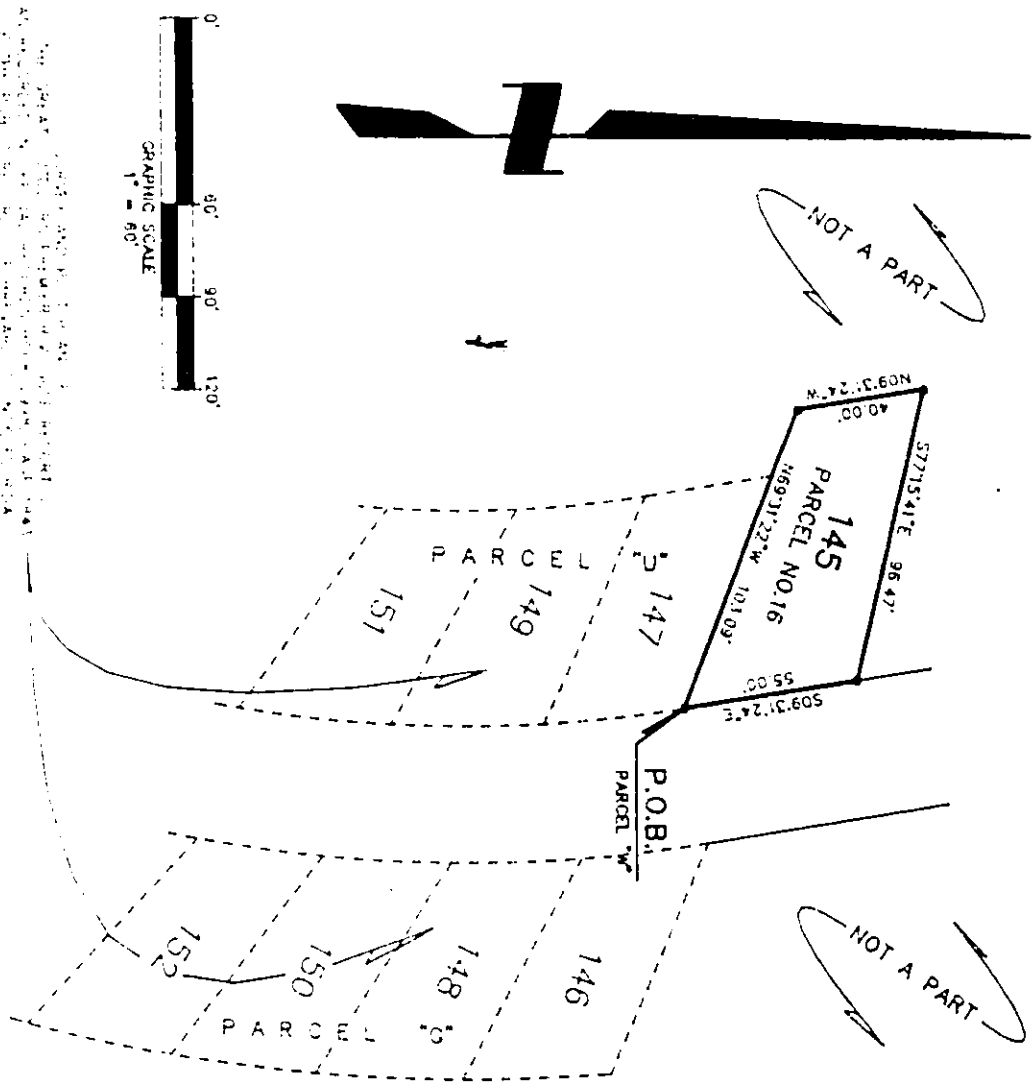
